## Sea Lion Splash Makes Waves as NEW Fair Attraction

WAUKESHA, WI (July 8, 2010) --- The **Waukesha County Fair Association** is pleased to welcome the **Sea Lion Splash show as a feature attraction** at the 2010 Waukesha County Fair, sponsored by Aurora Health Care. The show is FREE with paid admission to the Fair. The 168<sup>th</sup> Waukesha County Fair will run from Wednesday, July 21 through Sunday, July 25 on the Waukesha Expo Grounds.

Sea Lion Splash, sponsored by Tom's Heating Service, Carrier, Royal Prestige and WMIL FM106.1, is a 30-minute show that showcases the natural comedic behaviors of the sea lions. These behaviors include balancing, catching and retrieving objects, handstands, dancing, singing and interaction with the audience. The show is designed to educate the audience on the habits and nature of sea lions. The presentation is followed by the opportunity to watch the sea lions provide entertainment by being their natural selves. The show and exhibit is safe for the animals as well as the audience and is the only traveling sea lion show in the United States.

The Sea Lion Splash show is presented by Squalus Inc. The company was established when Marco and Kathi Peters began adopting and providing a permanent home for beached sea lions who were unable to be returned to the wild due to age or injuries. Because many of these injuries were direct effects of human carelessness, Marco and Kathi decided to educate the public on the plight of these incredible marine mammals and how we, as humans, need to co-exist together in harmony. So, they took their show on the road.
